Hall Ambulance Prepares for the Future of EMS

Recently, Hall Ambulance announced adjustments and promotions in its leadership structure as the Company continues its work with the County of Kern to reimagine the delivery of emergency medical services, building on its 52-year legacy.

On June 22, Mrs. Hall announced that she was appointing John Surface as president and chief executive officer effective July 1, and that he and Jackie Att, secretarytreasurer of corporate financial services, would join the board of directors. Mrs. Hall remains the sole owner but has transitioned to chairman of the board and chief administrative officer.

On July 19, as part of a management team restructuring, which Surface described as "in the best interest of Hall Ambulance," Myron Smith was promoted to vice president of Operations and Jenny Ramirez to vice president of Human Resources.

John Surface's introduction to EMS came as a fire protection specialist in the U.S. Air Force, where he advanced to assistant chief of operations. After transitioning to civilian life, he worked for the Walton Fire Protection District in Yuba City, California, rising to the rank of Captain.



As the newly announced president and CEO, John Surface has focused his vision on the future of EMS while staying true to the ideals on which Mr. Hall built his ambulance service.

He joined Hall Ambulance in November 1997 as a paramedic and served as a paramedic field supervisor from 1999 - 2001. In 2001, he was promoted to assistant manager of the ambulance division, becoming the manager in 2008. In 2016, Mr. Hall named Surface as vice president of Corporate Operations. In 2018, Mrs. Hall announced that Surface would become chief operating officer.

As he progressed in his career, so did his areas of responsibility where he has served as liaison with local, state, and federal government; state and national EMS associations; serves as the primary individual to oversee and maintain county contracts, and working with the CFO to develop concepts to maintain economic sustainability.

Surface is the president of the 911 Ambulance Providers Alliance and is a Mendiburu Magic Foundation board member. He is past chair of the California Ambulance Association's Political Action Committee and current member of the American Ambulance Association Political Action Committee, past president of the Bakersfield Kiwanis Club and Bakersfield Breakfast Lions Club, current member of the Westchester Kiwanis Club and involved in several other community organizations.

Surface holds the distinction of being a two-time recipient of the Founder's Award for Management Excellence.

Jackie Att joined Hall Ambulance in 1993 as controller, safeguarding and managing the financial assets of Hall Ambulance Service, Hall Air Ambulance, and Hall Critical Care Transport. In 2017, she was promoted to secretary-treasurer of corporate financial services/chief financial officer. She is responsible for producing financial statements and providing financial analysis, working with local regulators, initiating due diligence, and serv-

ing as the main source of financial input and guidance for all special products.

Among her academic achievements, Att was awarded a CPA from CSU Bakersfield and has a Bachelor of Arts from Fresno State College.

Myron Smith joined Hall Ambulance as a paramedic field supervisor in 1995 after his

family's ambulance service in Taft was acquired by Mr. Hall. In 2001, he was promoted to manager of Hall Critical Care Transport, overseeing the ground and air transport programs. In 2018, Smith became general manager encompassing a variety of responsibilities, including management of personnel, compliance, operations, continuing education, communications dispatch, and more.

From 2005 – 2018, Smith also served as program director of Bakersfield College's Paramedic Training, ensuring educational curriculum and content delivered to the program's paramedic students met or exceeded the National Standards guidelines.

His academic background is noteworthy and includes completing the American Ambulance Association's Ambulance Service Managers Program (2002), a Bachelor's and Master's Degree in Business Administration from the University of Phoenix (2002 and 2005), and a Master of Teaching & Curriculum from Fresno Pacific University (2020).

Smith has also received commendations, including Outstanding Service in EMS by the Kern County Board of Supervisors (2009), California Ambulance Association Star of Life (2015), Hall Ambulance Founder's Award for Management Excellence (2020), and Outstanding Graduate from Fresno Pacific University (2020). Jenny Ramirez joined Hall Ambulance in September 2019, bringing with her 15 years of HR-related experience in the agriculture, information technology, and business consulting arenas. Her accomplishments are well documented as she has transformed the H.R. Department to meet the needs of today's workforce.

Ramirez holds a B.S. in Business Administration from the University of Phoenix (2007), a Certificate in Human Resource Management from UCLA Extension (2009), an MBA with a minor in H.R. from the

Hall Ambulance Hosts Stop on National EMS Memorial Service's Cross-County Procession

Hall Ambulance was selected by the National EMS Memorial Service (NEMSMS) as the second stop and host site for its Moving Honors program, which took place on the morning of June 24.

The ceremony is a cross-country procession marking the countdown to the National EMS Memorial Service Weekend of Honor, recognizing EMS responders who died in the line of duty.

Moving Honors began the day before in Riverside and traveled 6,500 miles in 28 days before arriving in Arlington, VA, for the National EMS Weekend of Honor July 21 -23.

The ceremony was called to order by John Surface, followed by the presentation of colors by the Bakersfield Police and Fire Departments Joint Honor Guard.

Hall Ambulance Supervisor Joe Eastwood led the Pledge of Allegiance, with Bakersfield Police Department Chaplain Angelo Frazier offering the Invocation. Mrs. Hall welcomed the Moving Honors team and spoke to the importance of properly honoring those EMS workers who lost their lives in the line of duty.

Representing the National EMS Memorial Service, Tom Liebman shared details of the cross-country trek and the upcoming serving in Arlington. The Moving Honors Team, comprised of Meghan Haverkamp, Kari Spanarella, and Scottie Newlin joined Liebman to read the names of this year's 59 honorees, followed by a moment of silence and Amazing Grace performed by a Bakersfield Fire Department Bag Piper.

After the ceremony, those in attendance were invited to write a mes-

Model Solution for Rural EMS

Agreement Ensures Ambulance Service for Boron

The rural desert community of Boron, California, has a new advanced life support ambulance serving the community thanks to a unique relationship between the Muroc Healthcare District and Hall Ambulance.

The unit was placed into service on July 11 following a brief presentation in which President Karen Caillier presented the keys for the shiny new emergency vehicle to Operations Manager Darrell Stapley. Also in attendance were fellow board members Vieta Searcy, Shelley Keller-Gage, Darryl Caillier, residents Stuart and Charlene Sims, Mark Corum, director of media services, and Hall EMT Natasha Van Horne, who works at the Boron station.

Under the agreement, Muroc Healthcare District funds the ambulance's cost. In return, Hall Ambulance provides around-theclock paramedic service to the area's roughly 2,280 residents.

The relationship serves as a model solution for rural EMS, where the closest hospital emergency room is over 40 miles away.

Unit 542 is the eighth ambulance to be placed into service under this relationship dating back to 1994, replacing Unit 481, which was put into service in 2018 and served the community well, having logged over 296,000 miles of service. *****
